

Official Raffle Rules

Description:

To Enter:

Tickets are available for purchase on select items with the price per ticket specified on the item page at <http://mileoneacsauction.com>. Purchasing a ticket for a raffle item enters you into a drawing to win that particular item.

Prizes:

There will be one winner for each raffle item. Descriptions of raffle items, including their fair market value is available on the item page at <http://mileoneacsauction.com>. Items pictured are stock photos. Actual prizes will vary.

Taxes:

All winners of raffle items will be responsible for any applicable Federal, State, and/or local taxes related to the item.

Participation:

Entrants must be 18 or older to participate in the drawing or win a prize. Persons under 18 years of age may not be the beneficiary of a ticket purchase.

Entrants must be citizens or legal resident of the United States.

Selecting the winner:

Winners will be notified by text message or email within 48 hours after the raffle drawing on November 14th, 2019. Winners has 30 days from the date of the drawing to claim their prize and complete any paperwork associated with the process.

If a prize winner does not accept prize within 30-days, the prize will be forfeited and awarded to the back-up winner who will be drawn in the same manner as the winner.

Prize may not be transferred until after acceptance.

If a winner declines the prize, they must sign a Raffle Prize Disclaimer form.
